Preserving Guardians of the Past at Chelsea in Victoria

oncert Properties is continuing its tradition of preserving the past at its newest residential project in Victoria on Burdett Avenue, now named Chelsea in keeping with the charming English ambience of the neighbourhood.

Built in 1890, the original brick mansion was surrounded by lovely gardens enclosed by a brick and stone wall with wrought iron details. In 1918 the building was gutted by fire and the ruins were later torn down. The property became overgrown but was still enclosed by the fine brick and stone wall with ornamental wrought iron.

In 1939, the Sisters of St. Ann acquired the property and worked with the provincial government to develop Mount St. Mary Hospital – a care home for elderly patients.



During construction, care was taken to preserve the giant trees that stood as guardians of the past. Still standing today as a reminder of the site's heritage, the existing walnut tree, along with the original brick wall and wrought iron fences, will be restored and preserved in the new development so they may remain in perpetuity. Stabilization work on the wall alone will require six to eight weeks.

Located just blocks from Beacon Hill Park and Cook Street Village in Victoria's appealing Fairfield neighbourhood, Chelsea exemplifies the company's ongoing commitment to building Victoria's finest concrete residences.

Surrounded by historic homes, parks and treelined streets, the site is close to the waterfront and is within easy walking distance to dozens of restaurants, specialty retail and branches of all major financial institutions. Suites are large and spacious and feature 9' ceilings, generous decks and terraces, quartz countertops, stainless steel appliances and edge grain red oak hardwood flooring throughout all principal living areas.

The six-storey concrete midrise condominium project has 66 suites in a 97,000 square foot area. Suites range from one bedroom to two bedroom and den plus family room homes.

Presales of this new development are expected to begin in late September 2006, with construction activities commencing at the same time. Completion of construction and occupancy are anticipated for mid-2008.

Chelsea is Concert's third residential development in the Victoria market.

Concert Exceeds Goal for Building for Kids

oncert Properties' employees exceeded their Building for Kids goal and raised more than \$44,000 – the most contributed to the initiative by any one company.

For years, the BC Children's Hospital has provided sick kids treatment, hope and even life itself. In spring 2006, BC's real estate and development community joined together to help raise funds to purchase vital equipment for BC Children's Hospital through Building for Kids – a program that Concert proudly supports. This year's \$1 million goal was surpassed with the real estate industry raising \$1,002,600.

"In our industry we know the value of good equipment. We couldn't build our next project with outdated tools and therefore we can't expect those who save kids' lives to do the same," says President & CEO, David Podmore who is also the outgoing Chair of BC Children's Hospital Foundation. Brantford, Ontario Warehouse Now Leasing

dams Boulevard, Concert Properties' new industrial warehouse in Brantford, Ontario, is now being offered for lease to tenants.

The 16.5-acre property was acquired by Concert in the summer of 2005 and is located in northeast Brantford adjacent to the 200,000 square foot Adidas distribution centre, at 156 Adams Boulevard, acquired in June 2004 by Concert.

Adjacent to Highway 403, Adams Boulevard offers exceptional signage potential and is located in close proximity to Highway 401. The site has good access to the Greater Toronto area, the Kitchener/Waterloo/Cambridge region and Hamilton.

Features of the proposed building include large bay sizes, flexible unit sizes to accommodate both large and small tenants, professional ground level office finish, generous ceiling heights, abundant shipping /receiving bays and convenient surface parking.



Roughly rectangular in shape, the high-quality site is one of the last remaining highway frontage industrial development sites in Brantford.

Upon securing a lead tenant, Concert intends to build-to-suit to the tenant's needs and retain the building as a long-term income property in its portfolio.

Construction Activity

DEVELOPMENTS UNDER CONSTRUCTION IN BRITISH COLUMBIA

Belvedere, Victoria

At Belvedere, in the heart of downtown Victoria, landscaping is nearing completion and the 16-storey, mixed-use concrete tower will soon be ready to receive its first new owners. Staged occupancy is scheduled to begin in October 2006 with everyone moved in by the end of the year. Occupancy of Belvedere marks the completion of Concert's threephased development in downtown Victoria.

Circa, Vancouver

With landscaping and common areas recently completed, Circa will be home to its first owners, who begin taking occupancy in mid-September. The 22-storey tower with a four-storey base is the final tower to be constructed in Concert's Collingwood Village community – a master-planned community sixteen years in the making.

Saddleback Hills, Kamloops

Construction of Phase I of the Saddleback Hills development in Kamloops is now complete and over 98 per cent sold. Phase II, which was released in June 2006, is 85 per cent sold. It is anticipated that Concert will start the design of Phase III in fall 2006 with construction commencing in spring 2007. Once complete, the development will include 196 single-family lots, 32 townhomes and 48 bare-land strata

Tapestry, Vancouver

Concert's residential condominium project on the site of the Vancouver Hospital Nurses' Residence at 12th and Heather is progressing well. Selective demolition of the 10-storey structure being retained is largely complete. Concrete work on the new structures is well underway. Ground floor walls and columns are complete in the east tower, while construction on the ground floor walls of the north tower started on July 21. Construction of the new development is anticipated to be complete by late 2007.
